History Colorado has been building and refining its permanent collection since 1879. The Collection is a tangible point of connection between the present and the past. It reflects who we are and what we value today, and records what will be of interest to Coloradans in the future. The value of the collection lies in the powerful stories it holds, and in its potential for aiding public awareness and understanding of the state's history through uses including: research, educational programming, exhibitions, loans, design inspiration and community building.

With a significant representation of the state's history before 1940, History Colorado is currently focused on targeted growth of contemporary and diverse subject matter gaps in the permanent collection, including architecture. Staff is particularly interested in unique materials that document and record the stories of Coloradans after 1940. architecture. Equally important, the Associate Curator will focus on sharing those voices and stories in innovative ways across Colorado.

MAJOR RESPONSIBILITIES AND DUTIES:

- Promoting the mission and goals of History Colorado through cultivating and sustaining relationships with community groups, colleague institutions, partner organizations, educators, and researchers.
- Working with the Executive Director & State Historic Preservation Officer, Senior Curator and other staff to collect materials from significant Colorado architects (with consideration for existing HC collections), and to make those materials available to the public.
- Working with the Senior Curator and other staff to establish regional charrette groups to identify and prioritize notable architects, projects, organizations and collections in Colorado.
- Supervising the Colorado Architecture Diversity Fellow.
- Working to build a meaningful collection for the 21st century through the pursuit of a
 purpose-driven acquisition program tied to institutional vision and goals and the updated
 History Colorado collection plan in collaboration with other curatorial departments. This
 includes exercising judgment and consulting with other curatorial staff about the long-term
 historical value of materials already in the permanent collection and new materials offered.
- Assisting with the processing of incoming architecture collections via existing History Colorado processing guidelines and public catalogs.
- Assisting with the management, acquisition, research, and interpretation of architectural material as part of the larger History Colorado Collection.
- Improving physical and intellectual control of and access to collection resources through processing and documentation in coordination with Collections Management and Registration.
- Using a variety of approaches to outreach including public presentations, education
 programs, scholarship, social media, responding to patron and scholarly inquiries, and
 collaboration with other departments and divisions to realize the collection's full potential as
 an interpretive and educational tool and a resource for understanding Colorado history.
- Working with History Colorado philanthropy staff on incoming and potential financial donations.

- Experience with strategic planning and the ability to manage a broad variety of tasks in response to varying time pressures with shifting priorities and constraints.
- Familiarity with museum and archive databases, cataloging standards and guidelines.
